## Swing Bridge...

With the main work on the restoration completed this summer, we are now on the final leg of the landscaping and railings. We worked with local artist Mani and the community of West Oxford at their summer funday to create a bit of interest and a locomotive was installed on the hoardings in time for Oxford Open Doors as we await planning permission before the final works can happen. In the meantime, we have been delighted to learn that the Bridge has been removed from the Historic England 'at risk' register and that it has been shortlisted for a Railway Heritage Trust Award.



### Planning Update...

The Committee took to the stairs to get up high and see how pressure to build up could affect the dreaming spires of Oxford. This could include the buildings on the Oxpens site which are likely to be several storeys in height. We understand the need for greater density where development sites can happen, but when so much green belt around the edge of the city was recently lost to housing we would have hoped that the City Council who are developing Oxpens would have chosen to make it a new sustainable living quarter with houses for people who cannot afford Oxford's property prices and where they would be within walking distance of where the jobs are. It is a disappointment that so much of the site will go to innovation, science and technology buildings bringing more pressure to the city centre.

We engaged in the County's plans to remove the traffic from Broad Street, only 18 years after the OPT Broad Street Plan 2004 was published. We wholly support the initiative though have concerns about the traffic led approach with not enough thought given to the public spaces left behind, but seeing the car parking removed is an important first move. Changing behaviour requires dramatic plans, and the gates that will come next year reducing the traffic coming into and through the City will have a marked effect. They are good in their intentions though how it will work remains a concern as it seems to be a small part of a much bigger plan.



# Climate change and sustainability...

have been high on the agenda this year with some amazing OPT Green Awards and thoughts on our own meadows and issues of the environment and carbon capture. We have also been reorganising our committees to upgrade our work to better

include the green agenda and are delighted to welcome Trustee Dr Nick Leimu-Brown, international expert in tree and plant ecology and the restoration of ecosystems, who is looking forward to giving us a guiding hand.



Flood Alleviation Scheme crosses our Hinksey Fields. We feel sure there is a more sustainable way to protect Oxford from floods and save the environment. The same goes for the pressure to turn so much open green space into sites for solar panels. We understand the need for renewable energy and are calling on the Councils to come together and produce a strategy to decide where these should go rather than taking a piecemeal approach site by site.
